The Medicare Beneficiary Quality Improvement Project is a set of rural quality measures for Critical Access Hospitals to gauge their outcomes against other CAHs. Using its measures, hospitals can develop initiatives to improve outcomes and ensure they provide every patient the highest quality of care.

Navigating the data collection process connected to MBQIP can be complicated. The Kansas Department of Health and Environment, in partnership with the Kansas Hospital Association and Healthworks, is offering virtual abstraction training. This session provides an overview of quality data reporting and abstraction necessary for successful participation in MBQIP.

Specific topics covered in this training include:

- Components of quality data collection;
- Review of MBQIP measures;
- Review the Hospital Quality Reporting System abstraction process;
- How to report Emergency Department Transfer Communication Data Collection
- Review process of reporting EDTC measures to QHi; and
- How to develop and implement an action plan.
